Michigan Farmworker Jobs Paying \$13.54/Hour in 2019

Updated 07/20/2021

Several agricultural employers are seeking workers for agricultural jobs in Michigan that will pay at least \$13.54 per hour. The following chart lists the jobs available in Michigan. **These jobs are open to any qualified job applicant**, including migrant and seasonal farmworkers anywhere in the U.S. These agricultural employers often are posting these jobs as the first step to eventually bringing foreign guest workers to Michigan under the federal “H2A visa” program. If the employer finds enough qualified U.S. citizens or residents for these “H-2A jobs,” then they will need fewer guest workers. All able, willing, qualified and available U.S. workers who apply for these H-2A jobs before the “50% of the contract” date has elapsed must be provided employment. **If you are in Michigan and are interested in one of these jobs, you can call the Job Service office listed below. If you are outside of Michigan, you can call 1-855-633-2373.**

All workers, including U.S. workers, who apply for and obtain these “H-2A jobs”, have the right to the same terms and conditions. These jobs generally offer approximately 35 - 40 hours per week. Examples of benefits available to all workers employed in these jobs include:

- Hourly wage of at least \$13.54
- Free and licensed housing, if the worker does not live within commuting distance
- The cost of travel from the place of recruitment to the job site, if the worker completes 50% of the contract
- The cost of travel back home, if the worker completes the contract period
- A record of the amount of work performed and amount paid, including deductions
- Workers compensation insurance or its equivalent

Employers must provide free housing to any worker who is not from the local area. Some jobs specifically state family housing is available. Those jobs are identified in the chart. Other employers may provide family housing or may be required by law to provide family housing. **If you are denied a job based on your need for family housing or you are employed in one of these jobs and do not receive the benefits identified above, you can call Farmworker Legal Services at 1-800-968-4046.**

Farmworker Legal Services will counsel H2A visa holders about their rights under their contracts, U.S. workers who obtain these “H2A” jobs, and potential U.S. workers who are denied their right to obtain these jobs. An updated version of this list is available at www.FarmworkerLaw.org/H2A.
